  - b. Evidence of payment of Bar Practicing Fees and Branch Dues and Levies for the past three (3) years consecutively, inclusive of the election year, i.e. 2018, 2019, and 2020.  
The said Bar Practicing fees and Branch Dues must have been paid as at when due.

- c. Letter of Good Standing from the Branch Chairman of the Candidate, Nominator and Seconder respectively.
2. The Nominator and the Seconder must be as qualified as the prospective Candidate for the contemplated office.
3. Completed Nomination forms and accompanying documents should be submitted in a sealed envelope at the NBA national Secretariat in the manner stated on the Guidelines (or any other means as may be further advised by the ECNBA); with accompanying documents listed on a separate sheet.

*Further note that the collection and submission of the nomination forms in no way makes you a candidate for the elections. The ECNBA shall among other things screen prospective candidates by considering their forms and such other additional means as may be deemed necessary to determine eligibility to become a candidate.*
